MINUTES

Meeting was called to order by Supervisor Jim Roland at 7:00 p.m. Members present, Craig, Roland, Meagher, Ruth, and Mazure

Motion by Alice Craig, supported by Sam Meagher to approve minutes of 9-16-13 meeting. Motion carried.

Motion by Sam Meagher, supported by Mike Ruth to approve minutes of Garbage Roll Meeting of 9-30-13. Motion carried.

Duane Miller, Under-Sheriff for Huron County was present at the meeting, he gave a brief overview of the citizen complaints and traffic accidents in the township, also spoke briefly about the drug problems currently plaguing Huron County he also answered various question from the board members and the citizens from the township.

Motion by Jim Roland, supported by Theresa Mazure to hire Pat Riley for the 2013 -2014 winter season for snow removal at the township hall; pricing as follows: \$35.00 for each time he plows the parking lot and \$15.00 each time he shovels the sidewalk. Motion carried.

Jim Roland spoke about the Commissioners Meeting he attended, the Commissioners don't really want to handle any Blight Issues they feel it should be done at the township level. Talked with Jeff Smith from Building & Zoning about possibly changing the language on the Blight Ordinance, will report to the township board next month about

this. Jeff Smith did say he was thinking of issuing tickets to the offenders and work with the people that were trying to clean up their place.

Motion by Alice Craig, supported by Jim Roland to give the residents next to Bob Goodchild's house 2 weeks to see if the east side of their property continues to get messier then we will pursue with the county. Motion Carried.

Road repairs - the roads are done except for the French Drain on Weaver Road. There is a big chunk out of the bridge on Oak Beach Road and this needs to be fixed, it is the 1st bridge East of Oak Beach Road. We will be requesting money from Clancy & Sons Bond for Weaver Road

Motion by Jim Roland, supported by Theresa Mazure to transfer \$6,789.00 from the General Account to the Fire Fund Account. Motion carried.

Motion by Jim Roland, supported by Mike Ruth to have Alice Craig clean the township hall every 4 months at a cost of \$15.00 per hour and no more than 3 hours each time the hall is cleaned. Due to the sensitive files in the office only bonded people qualify for this job. Motion carried.

Motion by Mike Ruth, supported by Theresa Mazure to adjourn meeting at 8:00 p.m. Motion carried.
