DTE update: They promised one resident that she was going to be fully reimbursed but then they turned her down, and now they are going to reimburse her. We have contacted the Public Service Commission and they will help us to get DTE moving on necessary repairs.

Motion by Jim Roland, supported by Theresa Mazure to renew our Assessor, Val McCallum, employment contract for 3 years. The first year will be \$18,250.00 then a 2% increase for the next 2 years. Motion carried.

The sand pit on Weaver Road that is owned by Gene Clancy & Sons Excavating does have all the necessary permits in place. A resident had complained that they were

destroying the property and that is was zoned residential. The township will not pursue this any further.

Motion by Theresa Mazure, supported by Jim Roland to enter in an agreement with The View Newspaper to publish all of our township notices for one year, 2-1-20 – 5-1-21.
