Motion by Alice Craig, supported by Theresa Mazure to take \$250,000.00 from our Road Fund Savings account at Independent Bank and have our treasurer purchase a 12-month Certificate of Deposit at Thumb National Bank. Motion carried.

Motion by Theresa Mazure, supported by Sam Meagher to appoint one additional Board of Review member for 2024. Motion carried.

Motion by Theresa Mazure, supported by Sam Meagher to purchase a lateral fire file for the assessor at a cost of \$3,000.00. Motion carried.

There were not a lot of people that showed up for the Board of Review this year.

Motion by Alice Craig, supported by Sam Meagher to approve the 2023-2024 Budget. Motion Carried.

Motion by Theresa Mazure, supported by Matt Hyzer to approve the Hume Township General Appropriations Act. Roll call vote taken; all ayes. Motion carried.

Nothing was discussed concerning the Independent Bank charges.

Motion by Bill Goretski, supported by Sam Meagher to hire Michigan Chloride for dust control in the township for 2023 at the following costs; 2,000 gallons per mile which includes 2 passes but will have 1,000 gallons per lane will cost approximately \$460.00 per mile; 2,500 gallons per mile which includes 2 passes but will have 1,250 gallons per lane will cost approximately \$575.00 per mile. A booster application that would be applied between scheduled applications will be \$230.00 per mile. Motion carried.

Motion by Alice Craig, supported by Sam Meagher to increase copy costs for the treasurer to charge residents that need a copy of their paid property taxes to \$3.00 per copy. Motion carried.

Motion by Theresa Mazure, supported by Alice Craig to bring the following accounts back in budget: Account 404.00 Fire Revenue add \$46,144.00 more to the account budget. Account 336.813 add \$46,144.00 more to the account budget. Account 101.701 add \$500.00 more to the account budget. Account 674.00 subtract \$50000 from the account budget. Motion carried.

Motion by Theresa Mazure, supported by Sam Meagher to approve the Assessors Contract for 3 years. The first year's wages will be \$22,600.00 and 2% increase for the next two years. Motion carried.

Motion by Theresa Mazure, supported by Alice Craig to pay the 3-31-2023 year end payables. Motion carried.

Motion by Sam Meagher, supported by Alice Craig, to adjourn meeting at 7:42 p.m. Motion carried.
