Theresa is to purchase the plants at a cost not exceeding \$1,500.00. Motion carried.

Motion by Theresa Mazure, supported by Sam Meagher for Resolution #10-13 giving the Port Austin Township Library a donation of \$1,500.00. Roll call vote taken, all ayes. Motion carried.

The contract was signed from Nietzke and Faupel PC CPA's do the township audit for 2011–2012 Fiscal Year and 2012-2013 Fiscal Year; at a cost of \$3,500.00; and 2013-2014 Fiscal Year and 2014–2015 Fiscal Year at a cost of \$3,500.00.

Motion by Alice Craig, supported by Sam Meagher to move budget items discussed at our April 2013 meeting from the Contingency Fund. Motion carried.

Motion by Jim Roland, supported by Mike Ruth to give permission to Dr. Jim Dorais to have a fireworks display on 7-5-13, or if the weather does not permit then on 7-6-13. Motion carried.

Motion by Theresa Mazure, supported by Jim Roland to purchase new software for the assessor from B S & A Assessing Software at a cost of \$2,340.00 and for the treasurer at a cost of \$1,935.00. If we purchase it now we will get a 10 percent discount. These prices do reflect the discount. Motion carried.

Motion by Jim Roland, supported Alice Craig to hire Ron Clancy to repair the driveway at the cemetery in the township. Received 2 quotes from the following individuals; Dave Jimkoski quoted the following: 12" tube 30' long and gravel at a cost of \$675.00, Ron Clancy quoted the following: 12" tube 30" long and gravel at a cost of \$650.00. Job is to be completed by 5-27-13. Motion carried.

Tabled the road quotes until the June 2013 meeting because the quotes we were given were inconsistent.
