Thumb Electric Internet costs are as follows: for 250 mega bites per month it is \$85.00, for 1 gigabit it is \$120.00. Board felt that we would not be able to justify the costs and chose to stay with M3 Wireless.

Board Salary Resolutions – There were no board wage increases for this coming fiscal year.
