Flag concerns- We are having an issue concerning the replacement of the flag each month, due to high winds they are destroying the flag within a few weeks. Other options are being explored as to how we can solve this problem.

Motion by Theresa Mazure, supported by Sam Meagher to approve Resolution 03-2026, Treasurers Salary in the amount of \$19,000.00 per annum for fiscal year 2026-2027. Roll call vote taken, all ayes. Motion carried.

Motion by Theresa Mazure, supported by Alice Craig to approve Resolution 04-2026, Supervisors salary in the amount of \$17,000.00 per annum for fiscal year 2026-2027. Roll call vote taken, all ayes. Motion carried.

Motion by Theresa Mazure, supported by Alice Craig to approve Resolution 05-2026, Trustees salary as follows: \$70.00 per meeting, \$2,200.00 Stipend per annum for fiscal year 2026-2027. Roll call vote taken, all ayes. Motion carried.

Motion by Bill Goretski, supported by Theresa Mazure to accept the lawn care bid from Brad Strozski for the Cemetery and Township Hall lawn care. Township hall per cut \$45.00, Cemetery per cut (4 times per year) \$600.00, Cemetery Spring clean- up \$725.00 and may have an additional cost of \$300.00 for Cemetery clean up due to the high winds that will down a lot of tree branches. Motion carried.

Motion by Theresa Mazure, supported by Bill Goretski to accept the bid from Michigan Chloride Sales for dust control for 2026. Full application rate of 2,000 gallons per mile at a cost of \$480.00 per mile, 2,500 gallons per mile at a cost of \$600.00, if an additional 1,000 gallons need be applied per mile the cost will be \$240.00 per mile. Motion carried.
